WE NEED YOUR HELP!!! PLEASE COME AND HELP US SET-UP THE RING AND EQUIPMENT. WE WANT TO STICK TO OUR SCHEDULE OF **FIRST DOG ON THE LINE AT 8:30 AM SO THAT MEANS WE NEED TO START BUILDING AT 7:00AM. COME EARLY AND MISS ALL THE TRAFFIC.**

SITE INFO: This trial will be held in one ring outdoors on grass. You will be allowed to set up tents/canopies for crating around the ring. However, the Parks Department says stakes are not allowed. Set-up will be allowed after 7:00 am on Tuesday, Oct 5, 2010.

DIRECTIONS TO THE TRIAL SITE:

From I-5 South, take exit 307 for Hwy 99E toward Marine Dr. Keep right at the fork. Follow signs to Delta Park. Turn right at N. Union Ct., East Delta Park is on the right.

From I-5 North, take exit 307 for Hwy 99E toward Marine Dr., merge onto N. Marine Dr./NE Martin Luther King Jr. Blvd. Take the exit toward N Union Ct., turn left at N Union Ct. East Delta Park is on the right.

START TIME AND RUNNING ORDER:

Check-in time will begin at 8:00. **The first class will start promptly at 8:30 am.** This will be a 1 ring, 1 judge trial. The class running order will be as follows and will run small to tall:

Excellent FAST, Open FAST, Novice FAST, Excellent Standard, Open Standard, Novice Standard, Excellent JWW, Open JWW, Novice JWW.

ARMBANDS: If you marked that your dog has a permanent height card, armbands will be available for pick up at the trial secretary table in binders, alphabetical by Handler's Last Name. If you don't see your armband(s), then your dog needs to be measured or show a height card. There is no formal check-in. Please check in with the gate steward prior to running in your class.

MEASURING: All dogs without height cards will have to be measured by the judge of record, Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a judge available to measure dogs from 8 am to 9:30 am each day near the trial secretary's table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

PARKING: The Parks Department has requested that all parking be done "Head-In" only. Please, no parallel parking.

MOVE-UPS: The deadline for move-ups is Tuesday, September 28, 2010 at 6 pm and must be submitted in writing (email ok).

FOOD: The National Beagle Club will provide pizza for lunch.
