### **Move-ups:**

The deadline to send in your move-up is Monday, June 1, 2009 at 6:00 pm. Move-ups must be submitted in writing (email ok).

### **Height Cards:**

In order to expedite check-in, please consider emailing or snail-mailing a copy of your height card, if you did not send one in. You must present your height card or be measured **PRIOR** to running unless you are running at 24 or 26 inches. Our Judge, Laura English, is a VMO so those of you needing an official measurement for your height card will be able to get that. This also means that ALL dogs without height cards MUST be measured, regardless of jump height.

### **Start Time & Running Order:**

Check in and measuring time will begin at 7:00am. The first class will start promptly at 8:00am. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

#### **Sat: Tall to Small**

Ring 1: Excellent FAST, Excellent Standard, Open JWW, Novice JWW

Ring 2: Open FAST, Novice FAST, Open Standard, Novice Standard, Excellent JWW

#### **Sun: Small to Tall**

Ring 1: Open FAST, Novice FAST, Open Standard, Novice Standard, Excellent JWW

Ring 2: Excellent FAST, Excellent Standard, Open JWW, Novice JWW

### **Parking:**

There is ample parking at this facility. However, please be aware not to block the fire lanes.

### **Directions to Site:**

From I-5 take Exit #9 (in Washington), head West on 179<sup>th</sup> Ave. for ½ mile, turn left onto 2<sup>nd</sup> Avenue, then left again at Gate 7 (Purple Gate). Exposition and Equestrian Bldg is on the right at the end of the road.

Turn left onto NW Pettygrove St.

Southwest Washington Medical Center, 3400 Main St., Vancouver, WA 98663 (360) 256-2000 Head South on I-5 for 6.3 miles. Take Exit #3 onto Main St. and continue for 1.1 miles. Hospital is on the right.

### **Crating:**

There is plenty of crating at this site. All crating is on concrete, around the periphery of the rings. Please do not block exits/entrances, and do not crate on any elevated platform you may find around the ring(s). You may arrive for crating set-up after 4:00 pm on Friday.
