Trial Information: Trial statistics and other pertinent information will be posted at www.k-9sports.com.

Judging Schedule Change: We have had a change in the Judging schedule for this trial and as a result, some excellent runs will be judged by Craig Josling instead of Lavonda Herring. This is a change from the published Judging Panel and has been Approved by the AKC.

Saturday: Craig Josling will judge ALL Excellent FAST

Sunday: Craig Josling will judge All Excellent FAST with the exception of the 20" jump height.

Because of this change in the Judging Panel after the closing date, you may request a refund in full of the affected run ONLY if the following conditions are met:

- 1. You are affected by this change in Judging.**
- 2. You request your refund in writing (email is ok) before 8:00 AM on Wednesday, June 16, 2010.**

Move-ups: The deadline to send in your move-up is Monday, June 14, 2010 at 6:00 pm. Move-ups must be submitted in writing (email ok).

Height Cards/Measuring: All dogs without height cards will have to be measured by the judge of record, except 24" and 26" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a judge available to measure dogs from 7 am to 8 am each day near the trial secretary's table.

Start Time & Running Order: Check in and measuring time will begin at 7:00 am on Friday, Saturday and Sunday. We will begin each day promptly at 8:00 am. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

Fri: Small to Tall

Ring 1: Lavonda Herring: Excellent FAST, Excellent Standard, Excellent JWW

Ring 2: Craig Josling: Novice FAST, Open FAST, Open Standard, Novice Standard, Open JWW, Novice JWW

Sat: Tall to Small

Ring 1: Lavonda Herring: Excellent Standard, Excellent JWW

Ring 2: Craig Josling: Excellent FAST, Novice FAST, Open FAST, Open Standard, Novice Standard, Open JWW, Novice JWW

Sun: Small to Tall

Ring 1: Lavonda Herring: Excellent FAST (20" dogs only), Excellent Standard, Excellent JWW

Ring 2: Craig Josling: Exc FAST (All but 20") Novice FAST, Open FAST, Open Standard, Novice Standard, Open JWW, Novice JWW

Special Note: This trial is being held in conjunction with a Conformation and Obedience Specialty show so we will not have access to the Lure Coursing field or the grass area just south of the new arena.

Off Leash Areas: There will be no off-leash dogs allowed in the lure coursing field during this trial. Please keep all off leash activities confined to the designated, fenced-in paddocks. Retractable leashes will not be allowed at this trial.

And PLEASE pick up after your dogs.

Parking: We will be using the North driveway entrance (nearest the river) for agility. The South driveway is reserved for the Conformation/Obedience Specialty. We ask if you are crating in the building that you leave the up front parking area for those that are crating in their cars. Day parking is on a first come, first served basis. Please park in designated parking spaces only. Do not block building entrances or fire lanes.

Directions to Argus Ranch (35612 212th Way SE, Auburn, WA 98028):

From the North/South I-5 or SR 167: Exit at Hwy 18 East, take exit for Auburn-Black Diamond Road East, keep right. Turn right at SE Green Valley Rd. (just past Neely Mansion). Turn right onto 212th Way SE. Then turn left into Argus Ranch driveway. Follow signs for parking. Agility will be using the North driveway (nearest the river) for parking and RV's. The South driveway is for the Specialty parking and RVs.

From SR-169 Southbound: Turn right onto Roberts Dr. (in front of coal car). Follow Roberts Dr. approx 4 miles. Turn left at 218th St., Bottom of the hill is a stop sign. Go straight across over the cement bridge and take the first left into Argus Ranch driveway.

From SR-169 Northbound: Turn left at SE Green Valley Rd. Follow Green Valley Rd., approx 4 miles. Turn left at 212th Way SE, then take the first left into Argus Ranch driveway.
