This is your final confirmation for the EGRC AKC Agility Trial Sept 2-4, 2011 at Argus Ranch in Auburn, WA. **Trial Information:** Trial statistics and other pertinent information will be posted at [www.k-9sports.com](http://www.k-9sports.com).

**Move-ups:** The deadline to send in your move-up is Monday, Aug 29, 2011 at 6:00 pm. Move-ups must be submitted in writing (email ok).

**Height Cards/Measuring:** All dogs without height cards will have to be measured by the judge of record, including 24" and 26" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a judge available to measure dogs from 7 am to 8 am each day near the trial secretary's table. We will have a VMO at this trial so all dogs needing permanent measurements will be able to get one.

**Start Time & Running Order:** Check in and measuring time will begin at 7:00 am on Friday, Saturday and Sunday. We will begin each day promptly at 8:00 am. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

**Fri: Small to Tall**

Ring 1: Darryl Warren: Excellent FAST, Excellent Standard, Open Standard, Novice Standard

Ring 2: Terri Campbell: Open FAST, Novice FAST, Novice JWW, Open JWW, Excellent JWW

**Sat: Tall to Small**

Ring 1: Terri Campbell: Excellent FAST, Excellent Standard, Open Standard, Novice Standard

Ring 2: Darryl Warren: Open FAST, Novice FAST, Novice JWW, Open JWW, Excellent JWW

**Sun: Small to Tall**

Ring 1: Darryl Warren: Excellent FAST, Excellent Standard, Open Standard, Novice Standard

Ring 2: Terri Campbell: Open FAST, Novice FAST, Novice JWW, Open JWW, Excellent JWW

**Off Leash Areas:** There will be allowed off-leash dogs in the lure coursing field during and designated fenced-in paddock areas. Retractable leashes will not be allowed at this trial. **And PLEASE pick up after your dogs.**

**Parking:** We ask if you are crating in the building that you leave the up front parking area for those that are crating in their cars. Day parking is on a first come, first served basis. Please park in designated parking spaces only. Do not block building entrances or fire lanes.

**Raffle:** The Evergreen Golden Retriever Rescue will be holding a raffle on Saturday to benefit Golden Retriever Rescue. Be sure to check out all the wonderful items they have.

**Directions to Argus Ranch (35612 212<sup>th</sup> Way SE, Auburn, WA 98028):**

From the North/South I-5 or SR 167: Exit at Hwy 18 East, take exit for Auburn-Black Diamond Road East, keep right. Turn right at SE Green Valley Rd. (just past Neely Mansion). Turn right onto 212<sup>th</sup> Way SE. Then turn left into Argus Ranch driveway. Follow signs for parking.

From SR-169 Southbound: Turn right onto Roberts Dr. (in front of coal car). Follow Roberts Dr. approx 4 miles. Turn left at 218<sup>th</sup> St., Bottom of the hill is a stop sign. Go straight across over the cement bridge and take the first left into Argus Ranch driveway.

From SR-169 Northbound: Turn left at SE Green Valley Rd. Follow Green Valley Rd., approx 4 miles. Turn left at 212<sup>th</sup> Way SE, then take the first left into Argus Ranch driveway.
